# Fifth Provisional Merit List of Selected Candidates LL.M. Programme

- The Registration process of Online Counselling for admission to LL.M. Programme at National Law University Delhi had started on December 13, 2024 with last date for Online Counselling Registration as December 22, 2024 by 11:00 a.m.
- Based on the available vacancies, the Fifth Provisional Merit List of Selected Candidates for admission to LL.M. Programme is annexed as Annexure-A.
- Candidates listed in the Fifth Provisional Merit List of Selected Candidates for the LL.M. Programme are required to pay the fee by July 4, 2025, failing which the offer of admission shall stand cancelled, and the seat will be offered to the next candidate in order of merit among those registered for the Online counselling.
- The portal/interface for payment of Provisional Admission Confirmation Fee & downloading of Provisional Admission Offer Letter by the provisionally selected candidates will be activated on July 4, 2025.
- A candidate provisionally admitted to the Joint Master's in LL.M. (IPR) Programme and now listed in the Fifth Provisional Merit List for the LL.M. Programme may choose to switch to the LL.M. Programme. Similarly, candidates provisionally admitted to the LL.M. Programme may opt to switch to the Joint Master's in LL.M. (IPR) Programme if they feature in a subsequent merit list for the Joint Master's in LL.M. (IPR) Programme. To switch between programmes, candidates must accept the provisional admission to the newly offered programme by clicking the "Accept" button on their dashboard. Upon doing so, their provisional admission to the previously admitted programme, if any, will automatically be withdrawn. At no point, candidate can hold seats in both programmes simultaneously. Once option to switch a programme exercised or acceptance is made by clicking on "Accept" button, the decision will be final, and candidates cannot revert to the previous programme under any circumstances.
- The counselling fee and provisional admission confirmation fee paid for one programme will be adjusted toward the fee for the other programme. Any balance fee must be paid as per the applicable fee schedule.
- In case, the candidates do not accept the offer of admission for any reason whatsoever, it will not be reconsidered afterwards under any circumstances, and they will forfeit the right of

admission along with the right to refund the Counselling Fee. No request shall be entertained in this regard.

Provisionally selected candidates must download their Provisional Admission Offer Letter from their AILET-2025 account. To signify acceptance of the provisional admission offer, candidates are required to Sign each page of the Provisional Admission Offer Letter and upload the signed letter onto their AILET-2025 account, along with a signed undertaking by both the candidate and their parents. Further, the candidate is required to upload Annexure-B and Annexure-C along with the Provisional Admission Confirmation Letter. Even if certain information is null, relevant professionals must sign Annexure-C.
