The National Law University Delhi, established in 2008 by Act No. 1 of 2008 of Delhi is a premier Law University in the capital city of India. The University invites online applications for admission to Postgraduate and Ph.D. Programmes for the Academic Year 2026-27.

### POSTGRADUATE PROGRAMME

#### JOINT MASTER'S/LL.M. PROGRAMME IN INTELLECTUAL PROPERTY (IP) LAW AND MANAGEMENT - ONE YEAR

**Master of Arts (M.A.) in Intellectual Property Law and Management**

**Master of Laws (LL.M.) in Intellectual Property Law and Management**

**Eligibility:**

1. Candidates must have completed two bachelor's degrees in succession, including one in the relevant discipline; or
2. An integrated degree programme of five years in the relevant discipline after completing plus two; or
3. An equivalent post-graduate degree in any discipline from a recognized university;

In all the above mentioned cases, the candidate must have secured a minimum of 50% marks in aggregate (45% for reserved categories such as SC/ST/Persons with Disability).

**No. of Seats:** 25 Indian, 10 Foreign National, 5 CGPDTM

**Eligibility:**

1. Candidates should have completed LL.B. or an equivalent degree from a recognized University.

In the above mentioned case, the candidate must have secured a minimum of 50% marks in aggregate (45% for reserved categories such as SC/ST/Persons with Disability).

**No. of Seats:** 25 Indian, 10 Foreign National, 5 CGPDTM

#### POST GRADUATE INSOLVENCY PROGRAM (PGIP)- MASTER OF ARTS (MA) / MASTER OF LAWS (LLM) DEGREE IN INSOLVENCY\* - TWO YEARS

**Eligibility:**

- Candidates who have completed a basic professional course such as company secretary, chartered accountancy, cost accountancy, law, or a bachelor's in technology or a bachelor's in engineering or a postgraduate degree with a major in Economics, Finance, Commerce, Management or Insolvency with aggregate 50% marks.
- The eligibility for the Master of Laws (LL.M.) degree is completion of their LL.B. or equivalent, all other candidates will be eligible for Master of Arts (MA) degree.
- The maximum age limit for enrollment shall be 28 years on the date of the advertisement.

**Number of Seats:** The total number of seats for the program is 40.

\*The PGIP Certification is issued and authorised by the **Insolvency and Bankruptcy Board of India (IBBI)**.

A separate Master of Arts (MA) / Master of Laws (LL.M.) degree (One Year) in Insolvency is awarded by National Law University Delhi (NLUD).

## Ph.D. PROGRAMME

### Ph.D. IN LAW

**Eligibility:** LL.M. or an equivalent law degree with 55% marks (50% SC/ST/OBCs non-creamy layer/ Differently Abled/Economically Weaker Section).

**Total Seats:** 32+2 (UGC-JRF: 18 seats, AIET Merit -12 seats, Fellowship through AIET Merit -2 seats and Foreign Nationals-2 Seats).\*

### Ph.D. IN SOCIAL SCIENCES viz., POLITICAL SCIENCE, SOCIOLOGY, CRIMINOLOGY, ECONOMICS AND ENGLISH

**Eligibility:** Bachelor's Degree and Master's Degree in relevant Social Sciences or humanities with 55% marks (50% SC/ST/OBCs non-creamy layer/ Differently Abled/Economically Weaker Section).

**Total Seats:** 4 (UGC JRF, Foreign Nationals).

UGC-JRF candidates holding valid JRF certificates and Foreign Nationals are exempted from AIET. The University will follow the reservation policy as per the UGC Regulations.

\*In case UGC-JRF seats remain vacant, the same may be filled by eligible candidates selected through AIET Merit, and vice versa.

## TEST CITY

AIET 2026 will be conducted at the following Test Cities:

**Bengaluru, Bhopal, Chandigarh, Chennai, Delhi, Jaipur, Kolkata, Lucknow, Mumbai and Patna**

In case the number of candidates at any test city is less than 100, Test Centre will not be created in that city and candidates will be allotted test city as per their 2<sup>nd</sup>/3<sup>rd</sup> preference of test city.

## ONLINE APPLICATION FEE

Interested candidates must apply online by paying an application fee of Rs.3,000/- (Rupees Three Thousand only). The application fee for SC/ST candidates and Persons with Disabilities (PwD) is Rs.1,000/- (Rupees One Thousand only). SC/ST and women candidates who are Below Poverty Line (BPL) are exempted from payment of the online application fee.

## REFUND POLICY FOR UNIVERSITY FEES

1. The counselling fee is fully refunded if a candidate exits the admission process.
2. If the candidate proceeds with admission, the counselling fee is adjusted against the total payable fee.
3. In case of withdrawal of admission, the entire fee paid by the candidate, including the counselling fee, will be refunded in accordance with UGC guidelines issued from time to time.
