## A) ONLINE COUNSELLING REGISTRATION:

1. The counselling process for admission to NLU Delhi shall be conducted exclusively in online mode.
2. Based on the AILET merit list, category wise candidates shall be invited for online counselling registration, in a ratio of approximately three candidates for each available seat in the respective category.
3. All candidates are advised to login to their AILET account to check if they have been invited for online counselling registration.
4. Eligible candidates will receive an email/SMS on their registered email ID/mobile number for AILET 2026 inviting them for online counselling registration. NLU Delhi will not take responsibility for undelivered emails/SMS. An invitation will also be available on the AILET 2026 login of the eligible candidates.
5. The Online Counselling Registration Fee for candidates is as follows:
  - General/KM Category: Rs.30,000.00
  - ST/SC/OBC/EWS/PwD Category: Rs.20,000.00
6. Candidates must pay the Counselling Registration Fee before the specified deadline. Requests for payments after the deadline will not be considered under any circumstance.
7. The Counselling Registration Fee must be paid through digital payment methods like Credit/Debit Card, Net-banking, UPI, etc. only. Payment through any other mode will not be accepted.
8. **Candidates are advised not to wait until the last minute to make payments to avoid payment-related issues.** NLU Delhi will not be responsible for any payment issues. Candidates must wait for a **'Payment Successful' message**. Requests for late payments due to transaction failures or other issues will not be entertained.
9. Candidates must upload the following self-attested documents in serial order (in PDF format in one file) while registering for Online Counselling:
  - Candidates must submit the Statement of Marks of B.A.LL.B.(Hons.)/LL.B. or equivalent examination thereto securing in the aggregate not less than 50% of the total marks (45% in case of SC/ST/Persons with Disability) latest by June 30, 2026. **(in case candidate is appearing or result is awaited, the declaration needs to be**

submitted by the provisionally selected candidate at the time of provisional admission only).

- Marks Statement of X and XII Class Examination or equivalent Examination.
- The candidate passed in compartment in the year of the admission, would be treated as ineligible.
- Valid Character Certificate from the last attended institution (not more than six months old).
- Valid category certificate (PwD/SC/ST/OBC/EWS/KM etc.). **The OBC (Non-Creamy Layer) certificate should be issued by the competent authority under the Central List of OBCs or under the Delhi State List of OBCs (Notified by the Government of NCT of Delhi) on or after April 1, 2025. The EWS certificate should be issued on or after April 1, 2025.**
- **The required certificate(s) for reserved categories/ classes will be essential and to be produced in original at the time of provisional admission. No provisional admission shall be granted for want of caste/category certificate from the competent authority. Further, the caste/category certificate should invariably be in the name of candidate himself/herself and not in favour of respective parents/guardians/spouse or any other family members etc.**
- **It is the sole responsibility of the candidate to prove his/her eligibility for claiming reservation under any of the reserved categories/sub-categories. The candidates claiming reservation under SC/ST/OBC/EWS/KM/PwD sub-categories will be required to produce original certificate at the time of provisional admission & document verification.**
- The University will issue a category-wise provisional merit list only for candidates who have completed online counselling registration and paid the required fee within the stipulated time. Mere registration does not guarantee a seat.

### **B) PROVISIONAL MERIT LIST OF SELECTED CANDIDATES (CATEGORY WISE)**

1. Provisionally Selected Candidates (from 1<sup>st</sup> to 3<sup>rd</sup> Merit List) must pay the Provisional Admission Confirmation Fee of Rs.50,000.00 within the stipulated time and balance fee shall be paid by the April 30, 2026. **Failure to do so will result in automatic cancellation of the**

2. **provisional admission offer. No requests for extension will be entertained. The candidates selected in 4<sup>th</sup> Merit List onwards will be required to pay the complete fee as per the schedule mentioned above.**
3. Provisional admission confirmation Fee and balance fee shall be paid through the same login (AILET 2026 account) through which, candidates have registered for Online Counselling.
4. After payment, provisionally selected candidates must immediately download their Provisional Admission Offer Letter from their AILET-2026 account.
5. To accept the provisional admission offer, candidates must sign each page of the provisional admission offer letter and upload it to their AILET-2026 account along with a signed undertaking from the candidate and parents.
6. In case any vacancy arises due to withdrawal of admission or non-payment of balance fee (**Annexure-I**) by the provisionally selected candidate within the stipulated time period, the seat shall be filled up from the candidates of concerned categories who have registered for online counselling in order of merit.
7. Requests for fee payment after the deadline will not be considered under any circumstances. Candidates are advised to avoid last-minute payments to prevent payment-related issues. NLU Delhi will not be responsible for any payment-related issues. Candidates must ensure they receive a **"Payment Successful"** message and acknowledgment slip. Requests due to transaction failures or other issues after the deadline will not be considered.
8. The University will refund the counselling fee to candidates who successfully registered for Online Counselling, paid the counselling fee, but couldn't secure a place in the any provisional merit list due to higher cut-offs. The refund process will commence after March 15, 2026.
9. The University will hold the counselling fee of 10% of the total sanctioned seats of each category until the admission process is completed, refunding it after June 30, 2026, or upon the closure of admission process, whichever is later.
10. The counselling fee will be refunded to the same account used for payment. Requests for refunds to other accounts will not be entertained.
